

Here we are well into another year. So far we have had plenty of rain and a good snowpack which should help flush many of the pesky invasive plants from the Delta this season. In the Delta we are disheartened to see our new governor is still planning to divert the Sacramento River around the Delta. Hopefully he will work with us and see the damage this plan would cause to the entire watershed. We have been fighting the water war for 12+ years since Arnold Schwarzenegger declared it when he was governor. I was hoping for a break but it looks like it will go on.

When I was at the recent PL-CYA awards dinner I met Ron Young of the St. Francis Yacht Club. He is the recipient of the Lloyd Ryland Yachting Historian of the Year Trophy for 2019. He has fourteen years of experience as Chairman of the Wednesday Yachting Lunches at the club and has produced over 700 presentations.

He contacted me and asked if I would do a PowerPoint presentation about the history of yachting in the California Delta. I agreed to do it and relied on some of the information I have gathered over the years. Back when I was a young lad and was a salesman at Stockdale Marine in Sacramento at times we would have people give us old books, maps, and memorabilia. We would also collect items left on boats and even clean out a storage locker in an estate sale from time to time.

Mel Owen is a fountain of interesting material, especially about Grindstone Joe's. I have also spoken with Bill Conner, a friend and the former owner of Lost Isle from the days of the monkeys, goats, and peacocks roaming the island. Bill told me fascinating tales of the old Corps of Engineers boat *Suisun* renamed *Virginia S.* and was a live aboard for Tom Case and his wife for decades, first at McLeod Lake then at Lost Isle. Bill told

me about running out of fuel in the Stockton Channel and finding a gallon of gasoline in a Briggs & Stratton portable pump aboard, enough to get a mile or so downstream to Stephens Landing where they got Theo to bring out five gallons and were able to make back to Lost Isle. Bill said the Corliss engine had four Model T carburetors.

I gave a lot of material to Hal Schell, mostly old charts, maps, and photos but unfortunately when he crossed over the bar his collection of memorabilia disappeared. Since I have been with the Delta Chambers and Yachtsman Magazine I have amassed my own collection of ephemera that folks have sent me, sometimes anonymously. I will use this along with my own personal photos for the event in late February. The Spaulding Marine Center in Sausalito has also asked me to do a presentation, this will be on March 20 with the same material. If it is well received at both places I will see if I can get my resident videographer Gene Beley to record it for online viewing. What I have discovered while working on this is that we could produce volumes of history about Delta boating over the years. Just the history of the Northern California Fleet of the CYA is fascinating.

The Taste of the Delta will be August 3<sup>rd</sup> this year at Village West Marina in Stockton. We won't be having an official CYA cruise in but I can get discount tickets for any CYA member that wants to attend. It looks like the Sausalito Yacht Club is having a cruise in at the marina that weekend so dock space might be somewhat tight.

As the new year rolls in, the PICYA is now ramping up for work on its list of activities for 2019. First off was the Annual PICYA Change of Watch banquet, ceremony, and dinner dance that was held on January 26th at the Sheraton Hotel in San Rafael. Bill Gargan was installed as 2019 Commodore and Jim Sweeney joined the Board of Directors for a two-year term.

The first 2019 Board of Directors meeting was held at Aeolian Yacht Club on January 15th. The main order of business was to begin preparations for April 28th's Opening Day on the Bay. The theme is "Holidays on the Bay". The Opening Day Committee chairman is Robert Willis, PICYA Vice Commodore. Linda Abrams, chair of the Corinthian Y.C. Opening Day Committee, participated. Commodore Cruises will again furnish the Committee boat. On the water assistance will be provided by the Coast Guard Auxiliary. Current business:

- The call for member clubs to provide financial donations and/or other forms of assistance to U.S. Coast Guard families suffering under the partial government shut-down resulted in several good works. Notably, Loch Lomond Y.C. hosted a dinner for roughly 120 members of USCG families.
- The PICYA 2019 scholarship program is about to get underway. Donations and volunteers to review applications are needed. Scholarships of \$2,500 per student are planned.
- The next PICYA Leadership conference is sched-

uled for March 16th at the Martinez Y.C.

- Willow Berm Y.C. was inducted as the 106th member of the PICYA.
- Coastal Cleanup Day will be September 14th.
- The Margot Brown Wheelchair Regatta at Encinal Y.C. will be on September 28th. This is an annual event that allows wheel chair bound veterans to get out on the Bay for an enjoyable afternoon on the water. In a number of different categories, volunteers are always welcome.
- The RBOC is beginning work on California State

legislature 2019 business. Approximately 2,000 bills will be reviewed for their impact on recreational boating. Financial donations to RBOC are encouraged to fund this process.

- The next PICYA Board of Directors meeting will be held at the Aeolian Y.C. on March 18th
- The next PICYA Delegates meeting was held at the Benicia Y.C. on March 4th.





## Change of Watch Weekend, Sacramento—by Gerry Kamilos, Staff Commodore

For our 2019 Classic Yacht Association Annual Meeting and Change of Watch the Northern California CYA Fleet hosted a very special and successful weekend in Sacramento. Basing the accommodation and main events on the historic Delta King was a perfect choice as the vessel is the epitome of a classic boat rescue! Built in Glasgow Scotland and Stockton CA she was christened in 1927 and had an illustrious career as a passenger vessel commuting between San Francisco and Sacramento until the San Francisco Bay bridges made her service redundant. Serving WWII as a US Navy submarine net tender on San Francisco Bay she eventually was used as a rooming house in Kitimat BC before returning to San Francisco bay to be abandoned in 1984. After being partially submerged for 15 months, the Delta King was re-floated and totally restored by dedicated owners as a hotel moored in the heart of Old Town Sacramento - a great legacy for the CYA to honor.

The Host Committee who spent most of 2018 planning this event consisted of the chairs Alan Almquist and Bill Wells with committee members; Tom and Nancy Clothier, Scott Andrews, Rusty Areias, Jonathan Arambel, George and Candace Homenko, Cynthia McMillen, and Patrick Welch, and your staff commodore. The Host Committee orchestrated a perfect long weekend series of events. Starting with an informal gathering in the Delta King bar on Thursday, on Friday's Delta Tour over 50 members were transported to tour the Haggin Museum in Stockton, CA where the Stephens Brothers archives are held. A private tour was given of the museum's collection of art; the highlight was original drawings of several Ste-

phens boats as well as the very sleek 1927 Stephens 26' runabout on display. The Tour then paid a brief visit to Locke, a listed National Historic Landmark, which is a fascinating, charming, crumbling village founded by Chinese agricultural workers in 1915 after their neighborhood in nearby Walnut Creek was destroyed by fire. The tour then proceeded on to the Delta home of Rusty Areias with the intention of viewing his classic yacht, *Miss 102* (a 60' 1956 Stephens) and that of member William Parker, *Merganser* (a 36' 1936 Stephens), only to find that the yachts were not at Rusty's dock. The yachts were stuck behind a closed drawbridge, unable to pass through because of a mechanical failure that could not be fixed in time courtesy of the US Government shutdown. Piling back in the buses our group then drove a short distance down river and were able to view the yachts from the levee, watching as the captains spun the yachts around eventually turning back down river to head to their berths. After viewing the yachts, members were hosted for an amazing and generous luncheon at the spectacular historic private Walnut Creek estate "Orchard Gables" of NC Fleet CYA member Rusty Areias. While enjoying the great food and wine the group was regaled with stories of the home's historic past including the occasion of a drunken fight between Ernest Hemingway and "Trader Vic" Bergeron after which Hemingway was

made to sleep in the garden house, since that time called "The Hemingway House." Friday evening the Northern California Fleet hosted all attendees at an elegant welcome party at the Sacramento Sutter Club (founded in 1889) in its fully restored 1931 building. Dennis Mangers, a senior advisor to Mayor Darrell Steinberg, welcomed the Association members to Sacramento. The Sutter Club staff served

wonderfully prepared hors d'oeuvres with a full bar. Fellow CYA members were able to enjoy connecting and fellowship.

Saturday afternoon, after the first of the two business meetings, 65 members embarked on a hosted cruise on the Sacramento River for what fortuitously, after several days of on and off again rain, was a bucolic experience in lovely sunny weather. It soon became apparent that river cruise boat was going to face some significant challenges in navigating the river as the waters, because of the winter runoff, was full of floating debris and driftwood. At full throttle we made slow progress upstream against a near flood stage river while dodging large uprooted trees rushing past downstream. It became more exciting, especially for those near the pilothouse, when the engine overheat alarms sounded, likely due to floating debris clogging the cooling intakes or fouling the props. One of the engines promptly shut down leaving us with one engine battling the strong current. Either by good luck, or good intervention, the engine restarted just in time to avoid crashing on the bank, and now under control once again we flew downstream and back to the dock. The captain, who reported he had only docked the boat once before, won a round of applause after demonstrating his metal by maneuvering us smoothly onto the dock despite the raging current.

The social program culminated Saturday with the Change of Watch dinner and ceremony held in the Paddlewheel Room of the Delta King, which offered a direct view of the huge

paddlewheel behind the podium. This certainly would have been an especially interesting room in the days when the Delta King was underway. The change of watch ceremony was noteworthy in that, rather than scavenging the prior year flags to pass on to the new flag officers, our outgoing Commodore, Scott Andrews, set a new precedent by

Following his instructions the Commodores tilted the paddle simultaneously to quaff

their respective shot glass full of tequila, spilling nary a drop! The paddle and glasses have moved on to Seattle to be ready for Diane Landers and Garth McBride to repeat the toast at the PNW Fleet hosted 2020 50<sup>th</sup> Change of Watch.

Everyone left Sacramento invigorated with enthusiasm about the CYA, looking forward to an active 2019 and eagerly anticipating January 2020 and that 50<sup>th</sup> CYA Change of Watch. That important milestone mandates a massive turnout so **MARK YOUR CALENDARS!!!**

First up on the list was the entertaining talk by our own Bill Wells at the St Francis yacht Club on February 27<sup>th</sup>.

For a charge of \$79 to \$99 which includes a picnic lunch on board you can view the parade from this double-masted yacht.

whose parade is held earlier on April 20<sup>th</sup> from 10 to 4 PM, and the Benicia Yacht Club whose parade occurs at the same time as the Bay parade are other options for participation in this well attended event. Bill Wells, our Delta correspondent, will report on additional parades that will be held at other yacht clubs throughout the delta.

This year's CYA cruise calendar will be great fun and will include a number of new venues that we as a club have not taken advantage of for many years. Around the Bay the cruise-in to the San Francisco Yacht Club is certainly a treat not to be missed. We have just been made aware that KKMI, a popular boat repair facility has been hit with a lawsuit by a non-profit organization called California Sportfishing Protection Alliance (CSPA). This organization is run by a Bill Jennings. The complaint by this group claims that "members of CSPA use and enjoy the waters into which defendant has caused ... pollution to be discharged. Members use those areas to fish, boat, kayak, swim, bird watch, view wildlife and engage in scientific study including monitoring activities among other things. Defendant's discharge of pollutants threaten or impair each of those uses or contribute to such threats and impairments. The relief sought herein will redress the harms to plaintiff caused by Defendants activities."

The following is a part of response from KKMI in regards to these allegations. "Bird Watch" - As noted above, ex-

cept for the kayak launch ramp, the entire shoreline is dominated by wharfs and commercial maritime industries. Moreover, no native bird habitats are located along the Santa Fe Channel (this is a man-made channel) as the majority of the waterfront is paved or otherwise improved. How have CSPA members been prevented from bird watching by KKMI?"

Those who are familiar with the Santa Fe channel in Richmond know that most of the "impaired activities" cited by the CSPA are bogus, so what is this lawsuit really about? We will follow this because if a large company like KKMI loses the case, then every other boat repair facility in the Bay will be in peril and we may well wind up with no place to haul our boats in the future.

## History of the Bay—by Mel Owens

This is the story of three of our classic yachts and their service to the country in the US Navy during World War II. *Papoose* was delivered to the U.S. Navy at Treasure Island in San Francisco Bay on Dec. 9, 1941. She was assigned YP-118 (YP = Yard Patrol). It must have been about 11 in the morning of Tuesday Dec. 9 as the Navy had demanded all boats being taken arrive by 12 Noon.

Another boat delivered that morning was *Xanadu*, owned by R. Bekins. She was assigned YP-117. So as YP-117 and YP-118 were settling into Treasure Island, the next boat arrived, namely *Pat Pending*, owned by Don Owen. She was assigned YP-119. Within two weeks these boats had been painted Gray exterior, and terrible green interior, all over the beautiful varnished teak.



*Xanadu* was assigned to patrol out of Treasure Island. *Pat Pending* was assigned to Naval Net Depot in Tiburon, but spent the next 2 1/2 years patrolling 24 hours a day the Cable Nets placed across the Golden Gate entrance to keep Japanese Submarines out of the Bay. Armament included Bow Deck 50 Caliber gun and Depth Charges on middle deck. *Xanadu* is, unfortunately, now gone. Not sure where *Papoose* was assigned. For a time in the 1980's *Papoose* was in the Bay Area, first on the Delta, and then at Pier 39 in San Francisco and owned by the Wilson's. He passed away and Joan, his widow, finally

sold the yacht to Harry Blattel of Munich, Germany and Venice, Italy where the yacht now resides. Above is a photo of *Papoose* on patrol painted in Navy Gray.
